The Town Administrator shall devote full working time to the duties of the office." **(emphasis added)**.

George Knox seconded. Passed by unanimous voice vote.

Donald Denley moved to authorize bifurcation after the second failed referendum. Patricia Billings seconded. Passed by unanimous voice vote. (The Town Attorney will be consulted to determine feasibility of proceeding this way.)

Donald Denley moved to adjourn. Karen Madore seconded.
