- 6 Old Business:

Elaine spoke about CVC and what it means (Community Voice Channel). She mentioned that the Town Administrator from Bolton, Joyce Stiles does a ½ hour presentation and talks about what is going on in Bolton. She also has different business people as speakers and committee or board members to speak. Elaine explained all this to us as she has asked Eric Anderson our new Town Administrator to go on CVC and do the same type of thing so Andover will be recognized for what we do in town and our governing body, as well as, she would like different committee chairs to talk about what goes on of importance to town. Elaine said we could go onto cvcct.org and click on demand and watch any segment we wanted to see or hear about.

Elaine spoke about the Hartford Business Foundation of Public Giving. Dianne Grenier was the original point person to represent our town. The Foundation is prepared to donate \$100,000 - \$50,000 is available for immediate projects. This Foundation intends to donate \$100,000 to 29 towns. There will be a committee formed in Andover but no elected officials may serve on it.

Elaine mentioned there will be a special BOS meeting to hear the Long Term Planning Committee and what they have discovered in 18 months of hard work. She believes the meeting will be either September 23 or 24th. She mentioned staffing will be added for a senior coordinator who may or may not have several jobs worked into one. Remains to be seen.
