Section 7 Licensed Day Care – Andover Lake District – added 7.0.5 Houses of Worship & Cemeteries, 7.0.7 Family Day Care/Group Day Care, 7.0.8 Home Occupations, 7.0.9 Accessory Apartments, 7a – reviewed additions, municipal land use, public parks. Chapter 15 Signs – changes requested by Town, billboards authorized by Board of Selectmen on Town owned property, regulation on content. Signs placed at AES – height, size, and notification to Board of Education. Section 4.21 Lighting; - REMOVED

Section 5 Licensed Day Care - Andover Rural Design District;

Jed Larson MOTIONED to approve Section 5 Licensed Day Care – Andover Rural Design District as amended. Steven Nelson SECONDED. MOTION CARRIED 5:0:0

Section 7 Licensed Day Care - Andover Lake District;

Jed Larson MOTIONED to approve Section 7 Licensed Day Care – Andover Lake District with the exception of moving "Houses of Worship" and "Cemeteries" from a Permitted Use to a Special Permit Use. Steve Nelson SECONDED. MOTION CARRIED 5:0:0

Section 15 Signs (Public Interest);

Jed Larson MOTIONED to approve Section 15 Signs (Public Interest) changes as shown. Scott Person SECONDED. MOTION CARRIED 5:0:0

Discussion on billboard signs along fence at Veteran's Memorial Field, regulating content of signs (political, business advertising), authorization by Board of Selectmen, payment for using space, public interest, applications – update wording for billboards, could add more definition to requirements if needed.

Jed Larson MOTIONED to amend the proposed changes to Section 15 Signs (Public Interest) as Commission discussed to now read "d. Billboard signs except where specifically authorized by the Board of Selectmen or their designated representative on the fence at the Andover Veteran's Memorial Park soccer fields, and no more than 32 square feet". Steve Nelson SECONDED. MOTION CARRIED 5:0:0

Section 23 Lighting (Height & Intensity)

Jed Larson MOTIONED to approve the modification to the site and parking lot regulation (Chapter 23.5b) Steve Nelson SECONDED. Discussion on maximum lumens, sport lighting, height limits and restrictions. MOTION CARRIED 5:0:0

Jed Larson MOTIONED to amend the proposed changes to place an upper limit on the illumination based on appropriate athletic field lighting standards (standard does not include pickleball courts). No second on motion. MOTION CARRIED 5:0:0

Section 24 Definitions.

Jed Larson MOTIONED to approve changes to Section 24 Definitions. Scott Person SECONDED. Jed Larson ELIMINATED the billboard definition from Section 24 and added "as in a corner lot" at the end of the "Lot Frontage" definition. MOTION CARRIED 5:0:0
