1. Call to Order/Pledge of Allegiance

The meeting was called to order at 7:05 p.m. by S. Louden followed by the Pledge of Allegiance led by S. Louden.

2. Comments from the Public – Teacher Laura Bush thanked the Board of Education for their support this past year. S. Louden thanked the Teachers' Association.

3. Approval of Minutes

5. Celebrations

This will be the last meeting for reporter Geeta Sandberg from Rivereast. The Board wished her well. W. Covell was presented with a plaque for her eight years of service to the Board of Education. She was congratulated by all present. Her family was also present.

6. Reports

A. Chairperson's Oral Report

S. Louden noted that she is proud to be a Board member. We have accomplished a lot this year. Three contracts were negotiated, and the roof is nearly complete. G. Cremé and L. Hewett were re-elected. All members were individually recognized.

B. Assistant Principal/Director of Special Education's Report

Mad Science and Parent Engagement Night was held on April 26th for Pre K families. It was well attended. Registrations packets have gone out for Pre K students. We will know the enrollment number at the June meeting. Transition meetings for 504 students will be held on May 26th. The IDEA grant will be dropped off when it is completed.

C. Principal/Director of Curriculum's Report

Principal Briody reported that staff and parent surveys are open until Sunday. The D.A.R.E. Graduation will be held tomorrow night at 7:00 p.m. The trip to the Yard Goats game was great. Michelle, the bus driver, sent an e-mail saying how well the students behaved. Sixth graders have started the Smarter Balance testing this week, and it is going very well. Field day is June 2nd. There will be a cookout for families. The PTA held a Young Authors event last night. Over 50 books were published. Twenty-five students and families came to the event. The PTA has events planned during Teacher Appreciation Week. The School Climate Committee revisited the Mission and Vision statements. Revised statements were distributed. The Step Up ceremony will be June 20th in the a.m. The fifth graders can attend. There will be a breakfast celebration before the ceremony.

D. Superintendent's Report

1. Superintendent Doyen noted a letter from the State Department of Education regarding the audit. There may be fines for getting the audit in late. The Department of Education will do a report. S. Louden reviewed that the audit was due December 31st. The Board hired a separate auditor from the Town. The Town didn't do their audit. J. Linddy noted that the Town Meeting went very well. Superintendent Doyen noted the population of ticks has increased this year. Superintendent Doyen has spoken with the superintendent in Hebron. The use of pesticides is limited. L. Bush noted that children do a tick brush-off following recess. Teachers also have students do a buddy check. Students are sent to the nurse for removal of ticks.

2. Technology/Committee Presentation

The committee presented several items of technology that have been used in the classrooms this year. Dash the robot was demonstrated. Students can do some of the applications at home. It is not a requirement. Discovery Streaming, Epic and Green Screen Fun are some of the applications used on I-Pads in grades K-2. Seesaw is an application used by special education. Three teachers went to U-Conn today for a technology conference. D. Maguire commented on the progress of the Technology Committee. J. Linddy suggested that more Dash robots and I-Pads be purchased.

3. Roof Update

Superintendent Doyen is waiting for the last bill from Imperial Roofing. She has written to CHRO to release some of the funds.

The Town referendum is scheduled for May 16^{th} from 6 a.m. -8 p.m. Everyone was encouraged to vote. Signs need to be put up.

7. End-of-Year Projects

Superintendent Doyen distributed a new list of projects. Unexpended funds for this year will be used for projects. Superintendent Doyen has received a verbal estimate of \$70,000.00 for the water system. It is not possible to remove the water tank. The fire alarm panel needs replacing. Two AC units are leaking. Five exterior doors need repair and five cafeteria tables need replacing. Funding sources were reviewed. M. Russo discussed the water system and switches. Superintendent Doyen suggested doing that project after July 1st.
