Auditor starting on 2020-2021 town audit.

Town to determine new fund accounts for Connectivity Grant, American Rescue Act, and Recreation Committee. Minor staffing changes pending permission include adding additional hours in the Building and Land Use Department for Building Official hours along with reinstituting Board Clerk assistance on Monday evenings to help Zoning and Wetlands Agents with paperwork. The changes would add approximately \$5,000 total with suggestion to fund from the CIRMA rebate check. The Board of Selectmen wishes to add a custodian for all town buildings to be funded from the Building Maintenance Fund.

Provided a storm update regarding water damage. Bunker Hill Road bridge is closed until further notice. Roadwork update includes completion of crack sealing and shimming on roads. Public Works will now work on drainage and tree trimming projects. Public Works Supervisor Jay Tuttle and Eric Anderson were featured on NBC Connecticut News sharing how Andover's tree trimming is to help keep power on during storms.
