8 Building & Grounds: Administrator **removed some phone numbers** from the Town's phone bill and also removed the use of the digit 9 prior to dialing numbers. This caused issues with phones in the Fire Dept. (FD). Frontier (phone co.) finally fixed the issue – except FD still had an issue and had to call in Simplex. Issue was fixed without having to replace anything.

Fire Dept. furnace was turn on around 10/30. The system stated making noise. Nutmeg was called in to check it out. A Circulator Pump had to be fixed. They also advised that possibly next time they may have to be replace.

Oil Level – Commission Williams advised there are 678/gallons in tank. Commission Chair advised that Dime Oil is still vendor suppling the fuel. Commissioner Williams will contact Dime to get a fuel deliver – since the propane conversion has not been done yet.

At Novembers Selectmen's meeting it was discussed that the Town Office Building is looking into updating their computers to **Hi-speed Service** and talked about "hooking up" to the Fire Departments fiber optic service. The Town might be able to take the service directly off the poles and not touch the FD's. If they "hook" into the FD's – it could cause issues with their hi-speed.

The Chief advised that the Administrator asked him if the Fire Dept. would **burn the pile of brush that is at the Transfer Station.** The Administrator was told by Commission Chairman prior to him asking the Chief - that the FD does not burn the brush any more. Administrator advised it would cost the town \$10,000+- to have the pile chipped and removed. This is because the pile is extremely large. After discussion back and forth Fire Commission voted to have the FD stand by while the Town Crew burn the pile. The FD will not be doing the burning.

Motioned for the Chief to talk to the Administrator and advise him that the Fire Department will help this one time and stand by while the Town Crew burns the pile. The Town must take corrective action to prevent this issue from happening again.

Motioned by W. Barton 2nd by M. Williams 2 - Opposed 3 - Approved
