6 Approval of May 13, 2019 Minutes: Motion to accept 5/13/2019 minutes as presented.

7 Financial Report: A) Treasurers Report - \$31,785.49 in checkbook

Treasurer reported that the Propane Tanks are FULL. Chief advised heat was turned off since Easter. Commissioners are still waiting to meet with installer to make sure there are no installation issues.

Treasurer presented a proposal for how Cost Recovery and Officer Stipends would be processed for the budget year 2019-2020. After discussion a Motion was presented.

Motion to Approve Treasurers Cost Recovery and Officer Stipends Proposal for 2019-2020 Budget year. Motioned by W. Barton 2nd by M. Williams APPROVED BY ALL

Sears and Son presented a bill for Loam, Fertilizer and Seeding that was a little higher than expected. After discussion a motion was presented.

Motion to pay \$1,310.00 to Sears and Son for Loam, Fertilizer and Seeding Fire House property. Motioned by C. Dowling 2nd by M. Williams APROVED BY ALL

After discussing what bills need to be paid with the budget for 2018-2019 Treasurer reported that they have left a little left in the budget for any additional issues or bills.

C) CIP Parking – A member of the CIP presented CIP members proposal for various "simple" improvements to town property. One is installing an asphalt walkway and perpendicular parking spaces at the Town Fire House. The Fire Commission CIP member sent this "proposal" to Commissioners for them to know about it. At this meeting Commissioners discussed what was proposed and if and when the CIP or Town Selectmen present the suggestion to be done then the Fire Commission would review and decide what would or wouldn't be done.

D) Sealing Parking Lot – Town received Bid for sealing school, town office and fire department parking lots. Fire Commission's part of the bill would be \$4,100.00. Timeframe for Fire Dept. lot to be sealed would be in July 2019. Coordination must be done for Fire Dept. vehicle access.

Commissioner Dowling brought up a request to **move the new shed** off the parking lot to another area that would be more acceptable to access and later on easier to put electricity to it.

\$1,200. Will discuss more once more information from insurance is provided.
