A) Treasurers Report - \$30,673.05 in checkbook

Even with a note left in the oil tank to make sure the delivery person did not leave any oil. This is a \$2,000+- bill that was not expected. Tonight - Commissioner Wright provide the Chief with another name and after discussion it was decided to check this new contractor out and if they are within the same pricing as the first company then Chief will decide who to go with.

(Pricing provide by 1st company was: \$125wkly cleaning, \$275 for cleaning windows, \$1,275 refinishing floors)
