1. Call to Order/Pledge of Allegiance

3. New Business

Discuss and act upon the following:

A. LOCIP funding for Transfer Station paving RFP discussion

Town Administrator Eric Anderson provided an outline of expenses and members discussed options for the project.

Adrian Mandeville MOVED to approve the use of up to \$65,000 of LOCIP funding for reclaiming, grading, paving and drainage for the Andover Transfer Station.

B. LOCIP Funding for Veterans Memorial discussion

Town Administrator Eric Anderson provided options for upgrades and members discussed the project. Adrian Mandeville shared that there is a list of questions needing to be addressed for the property. Scott Person and Eric Anderson are researching the property and addressing the questions. No motion necessary.

STEAP Grant Funding for Roadwork

Town Administrator Eric Anderson provided a Roadwork Summary and Spending to Date. STEAP is the Small Town Economic Assistance Program (CGS Section 4-66g) funds economic development, community conservation and quality-of-life capital projects for localities that are ineligible to receive Urban Action (CGS Section 4-66c) bonds. Eric shared that he does not believe funding is appropriate for the future Community/Senior Center due to numerous variables. He proposed idea to use the grant funding for road work projects. Members discussed the proposed ideas.

Jeff Maguire MOVED to authorize the Town Administrator to submit a STEAP grant for Reclaiming and Paving Long Hill Road from Route 6 to Bear Swamp Road, and Shoddy Mill Road from Route 6 to Wales Road. Adrian Mandeville SECONDED

Discussion: Jeff Murray questioned if the leftover Connectivity Grant funds can be used for road work. Eric Anderson confirmed that they cannot.

Adrian Mandeville MOVED to amend the motion to include for the Town to also complete the paving on Long Hill Road with the STEAP grant funding.

D. Athletic Field Usage

Members reviewed the Town Facility Request Form Agreement and the Athletic Field Use Agreement from Kyle Ayer, Vice President of FSC North soccer club.
