Discussion on the budget, where cuts can be taken (education?) and the effects on the mill rate. The Towns overall budget is discussed and what the money is used for, infrastructure/the management of the Town (several issues) and the Governors proposed Budget.

The Board decides that they do not want to go through each line Item that the BOS submitted to the BOF and that will remain as submitted.

**Cathy Desrosiers** explains to the public present that they need to go to the BOF Public Hearing on April 26<sup>th</sup> to voice their opinions/concerns.

### Agenda Item 9a: Zone Changes/Trails Report:

**Eric Anderson** presents a report to the Board in regards to the items that the Planning and Zoning Commission has been working on (available in the Building Dept.). He discusses this report and explains various sections in the report.

## Discussion on this report

**Eric Anderson** asks that the First Selectman sign a letter addressed to the DEEP in regards to the graffiti on the Hop River Tunnel. He also discusses what other Towns have for walking trails and what the Commission is trying to accomplish be adding these Town trails. This would need the approval of the BOS. He goes over the properties that the Commission is proposing to have Town trails go through and would like the Board to consider this future endeavor . In closing Eric states that there should be a Public Hearing held at the P&ZC Meeting in May where this will be discussed.

## **Item b: Talbot Property:**

**Eric Anderson** explains that the Commission at first was interested in this property as priority conservation land however the Commission decided not to pursue it due to the cost and the access to the property. He also mentions a bike ride that will take place on June 3<sup>rd</sup> on the Andover Trails and gives the details on the ride.
