- 2 d <u>105-320 Annual Audit Auditory</u> Bob Burbank requested that the Auditor's budget de decreased by \$ 4000.00. Jeff and Jay are concerned that the Audit has not been completed for this year and it could be higher next year. We will review this at the next budget workshop. No vote was taken, only discussion.
- 2 e 101-100 Wage First Selectman Bob Burbank requested the \$49,678.86 First Selectman's salary for 2017-2018 fiscal budget remain the same as he feels he will be working 40 hours a week training the new Town Administrator. No vote was taken, only discussion.
- 2 f 123-530 Telephone Old Town Hall Decrease \$ 500.00 from \$ 500.00 to \$ 000.00. No vote was taken, only discussion.
- 2 g <u>123-490 Alarm System Old Town Hall</u> Increase \$ 500.00 from \$ 250.00 to \$ 750.00. No vote was taken, only discussion.
- 2 h <u>129-530 Telephone Town Office Building Increase \$ 1350.00</u> from \$ 9,500 to \$ 10,850.00. It was requested that First Selectman obtain quotes from other telephone carriers to put the Town phone system out to bid. No vote was taken, only discussion.
 - 2 I <u>011-100 Tax Collector</u> <u>Decrease \$ 10,799.00 from 42,239.05 to \$31.440.00</u>
