 - c. Friday Sr. Lunch Program: State Health concerns with unlicensed servers and food at the OFH, Cathy is applying for exception requests every three weeks. She is looking into scheduling 5-7 volunteers to take the servicing class in order to serve the food that is provided by an outside commercial vendor and costs associated.
 - i. Cathy also looking into having the OFH water tested to allow coffee/tea making at the OFH
 - d. Concerns for Seniors home bound and Hop River when town Power Outages occur.
 - i. Cert, Paul Bancroft, handled the power outage down at Hop River. Seniors used the community building on site for warmth and electricity (24 hours). Clients had to bring their own food and comforts. Walks were shoveled but mnay need assistance to get to community building. Seniors went back to their apartments for overnight, then back to community center.
