- III. New Business:
  - a. Vendor Update: We have two new farmers that contacted Amanda about participating – Window Box Farm in Vernon with veggies, jams, cookies, etc

Harvest Grow Farm in Columbia has veggies, fruit, hot sauce and jerk seasoning.

East Willow Farm has a connection with a meat and chicken farmer that they will sell.

Suzanne works with the Willimantic COOP and will look into the farms that give them eggs and cheese. Maybe she can get someone who does mushrooms.

Amanda is talking to a donut person.

For food, the church is planning on doing popcorn, coffee, soda (Hosmer). Beth is looking into getting popcorn kernels that are locally produced. The cub scouts will be doing bake sales.

The cub scouts are going to sell plants.

Lucie will check with ALPOA to see what they want to do. She is now on the ALPOA committee.

b. Marketing Plan:

Amanda was able to get 75 AFM posters printed for .25. They look great and were handed out to people to display where they can.

Kaila Will create an individual event for Facebook for each market date. She will adjust according to the theme of the market.

Beth has updated the church's Facebook page and will advertise the market in it. She will look into Instagram since most of the AFM members like to use that. Easier than Facebook.
