Agenda Item 1: Call to Order: Dan Warren, Board Chair, called the

meeting to order at 7:03PM

Agenda Item 2: Pledge of Allegiance

Agenda Item 3: Public Comments:

Curt Dowling speaks on re-instating the funding for the Resident State Trooper and cites what other Towns have for funding in their budget. **Deborah Scanlon** speaks on behalf of the Trooper and comments on what was printed in the paper. She also inquires about the new cost for the Transfer Station and why residents were not notified.

Scott Warren supports the BOF decision to remove the Trooper from the Budget and he explains why.

Robert Burbank states that he visited the barracks an spoke with them regarding the force. They stated hat the Troop is down approximately 30% and the response time will be slower. Bob also notes that nights and

special events can be added to the Troopers requirements and that the BOS voted to put the Trooper back in the Budget.

Joe Higgins introduces Barbara, the new Town Hall Treasurer who will be starting on Monday.

Sally Doyan, School Superintendent speaks about what the Resident State Trooper has historically added to the school for (approx.) the past 20 yrs. She does however state for the record that that she has no official position on this decision.

Dan Warren addresses what Curt brought up in the beginning about other towns, specifically Canterbury. He note that these are elected Constables and he explains what there function is (clearly not the same as the Trooper). He also clarifies why the Meetings were held on the dates that they were. Dan notes that with the Budget provided to the BOF from the BOS and the recommendations provided by the CIP Committee will affect the mill rate as follows; 3.04 increase =35.54 and with the budget presented at public hearing 1.8 increase=34.3 mills.

Agenda Item 4: FY19 Budget:

Dan Warren begins the discussion on the Budget line Items beginning with the Resident State Trooper.

Discussion/recommendations on the budgets that were presented to the BOF for consideration and how they should proceed. (there was not enough time for the BOF to review the ones presented to them before bringing the Budget to a Town Meeting). Future Budgets and the procedure/Referendum also mentioned.

Dan Warren Motions to reduce under Budget Line Item 141-215, Health Benefits from \$230K to \$200K and increase Dental under Line Item 141 from 12K to 20K due to the Insurance Company information that was provided to him.
