Jay Linddy comments on the proposed Budget and the possible response from the Town employees.

Agenda Item 6: Budget Requests:

6A. Board of Selectmen Requests:

Dan Warren states that the Budget that was submitted last week along with the Governors proposed Budget including the proposed decreases in this proposed Budget will equate to a 7% tax increase. He then asks the Board of Selectman to voice their concerns and recommendations on how to decrease this tax increase before the informational meeting and the Public Hearing.

Robert Burbank states that the lost revenue has been through education which makes up approximately 80% of the budget. The Town can not absorb this type of increase and the cuts in the Town Hall are a small part of the Budget.

Adrian Mandeville questions Bob Burbank on the RHAM Budget.

Dan Warren states that he would like to discuss the BOS Budget right now and they can discuss the RHAM Budget later.

Julia Haverl (first comment on the education budget inaudible) discusses the Public Safety Line Item that was reduced to zero. She states that she is opposed to the removal of the Resident State Trooper.

Discussion among the BOF Members and the BOS Members present on the Education Budget and the Town Hall Budget

Dan Warren talks about the increase in the RHAM Budget and it equates to and increase of \$320K in taxation which includes the decreases.

Jeff Maguire discusses the taxation and the expenditures. Dan Warren discusses this with him.

Adrian Mandeville asks Julia Haverl about her concerns on cutting the State Trooper?

Discussion on the Resident State Trooper, what it saves the Town by eliminating this position and the value or lack of having the State Trooper in Town.

Dan Warren clarifies that the reduction of the State Trooper and reduction in Benefits equates to \$225K

Jay Linddy talks about the education Budget and the proposed cuts in the Town Hall Budget

Discussion on the Education Budget

Dan Warren asks if the BOS has any suggestions as to cutting the Budget? As it stands there will be a 3.63 increase in the mill rate and that is with the elimination of the State Trooper and the decrease in benefits. He states that they still need to cut approx. \$200K

Jeff Murray the Town can not take anymore from RHAM

Discussion on the cuts that have already been taken

Julia Haverl does not believe that any reduction can come from the BOS Budget.

Discussion on BOS budget cuts. Public Works cuts discussed

Dan Warren goes over the reductions; Town Administrator salary and how it was crafted which came out to approx. 80K could it be reduced to \$75K?, Auditor 105-320 keep the same? Dan asks Jeff Maguire if he has any recommendations, discussion, Treasurer salary 109-100 increased however he believes it can be reduced? Discussion. Jeff Maguire recommends 22K.

Discussion on the Treasurer

Jeff Maguire and Dan Warren discuss the Budget were the Town can get more cuts, main topic is benefits line item and the insurance changes coming.

Dan Warren asks Bob Burbank about the assessors salary and he replies that he is meeting with the Town Attorney in the morning on this subject/the contract.

Discussion on pay raises. Only elected officials and union workers will get contracted wage increases. General discussion among the BOF Members and the BOS Members on the proposed Budget.

Discussion on the CIRMA policy and what the increase is expected to be. Bob to find out what the numbers are and report it to both Boards.

Eric Shevchenko comments on the snow removal line item (inaudible)

Discussion on this line item. Bob explains how the sand and salt is budgeted.

Jeff Maguire asks the First Selectman to find a 6% cut in the BOS Budget or the BOF has to make more cuts.

Discussion on where the BOS can cut and where they can't (salary/hours included)

Dan Warren states that there is only so much the BOF can do and the BOS has to approve it.

Discussion on the BOS making cuts, where it can come from and can they have information in a week for the BOF?

Jeff Murray questions the Fire Commission on their Budget asks if they can make any cuts? **Wally Barton** explains why the budget is at where It is. He will however look at if it can be reduced.
