position has been under funded in time and salary for many years. BOS wants to know what attributes IWWC would like from a wetlands agent.

Eric Anderson suggested that IWWC use an application checklist like P&ZC uses.

Eric Anderson presented a letter to IWWC that is being presented to all of the town commissions. The letter asks for a commission synopsis and for a representative to attend the Wednesday, September 11, 2019 Board of Selectmen Regular Meeting. The commission will submit a copy of the ByLaws, summary of previous applications, and future goals and accomplishments. It is needed for the annual report as well.
