- a) Gravel Pit 517 Route 6- Andover Zoning Agent Jim Hallisey gave an update on the conversation with Chris Bell. - a) Zoning Agent- Enforcement actions, pending applications- Zoning Agent Jim Hallisey reported:

An application has been received for an accessory apartment on Aspinall Drive at the top of March 2023. A public hearing will be slated for April 2023.

Enforcement Actions update:

- 39 Jurovaty Rd, Deck Permit application submitted
- 43 Times Farm Rd, someone living in an RV. I have not heard back from the property estate contact, as of today. I will follow up.
- 27 Hendee Rd, a lot of garbage on the property. They have been sent a letter. A house has been under construction since 2019 and will hold the C.O. until all garbage is cleaned up.
- 68 Bear Swamp, there was a person living in an RV, and it appears to be resolved.
- 87 Merritt Valley Rd, last letter sent on 2/9/23, Landscaping business operating from the home. It is an industrial zone. I am working with the owner regarding a home occupation in an industrial zone permit approach which is permitted in our rules.
- 11 Bunker Hill, asphalt millings on the property in the flood zone, have been removed.
- 243 Long Hill Rd, Abandoned home. Will follow up.
- 64 Long Hill, Home under construction a lot of debris. Sent a follow-up letter, this property is now incurring a daily fine.
- 12 Center St, the house was demolished, monitoring the progress.
- 664 Route 6, This is ongoing with Steve Barnett, storing junk, progress is slow, but monitoring.
- 349 Route 6, Fence next to the library, hopefully, resolved by end of April. The owner has materials for the repair.
