1. Call to Order

Vice Chair Robert Hamburger presented documents via projector screen.

Zoning Agent John Valente shared the CRCOG Report on Zoning Referral.

a. Open Public Hearing

Eric Anderson OPENED the Public Hearing at 7:04 P.M.

i. Home Occupation Regulations

Discussion from the public: Dianne Grenier voiced opinion on general feeling that regulations are too restrictive.

Open discussion with commission for any comments, questions, concerns, etc.

Dianne Grenier left the Special Meeting & Public Hearing.

ii. Accessory Apartment Regulations

Open discussion with commission for any comments, questions, concerns, etc. None.

iii. Parking Regulations for Commercial Vehicles and Signage Requirements

Open discussion with commission for any comments, questions, concerns, etc.

Leigh Ann Hutchinson shared concerns on overnight vehicle parking. Jed Larson brought up how to parking of vehicles in backyard is precluded from section 4.19.4. Leigh Ann Hutchinson confirmed it states, '...these measures may include, but are not limited to:"

Zoning Agent John Valente questioned the wording of the 4.19.4 header with "...and noise of the vehicle storage..." Bob Hamburger confirmed that Town Attorney Mark Branse understood and approved the document. Commission confirmed that the storage includes process of moving vehicles to storage.

iv. Proposed Zoning Regulations for Keeping of Animals

Open discussion with commission for any comments, questions, concerns, etc.

v. Solar Access Regulations Subdivision and Zoning

Open discussion with commission for any comments, questions, concerns, etc.

Chair Eric Anderson abstaining from discussion on Item 3.a.v due to employment in the solar industry.

Zoning Agent John Valente addressed issue of solar energy within historic districts.

vi. Lighting Regulations

Open discussion with commission for any comments, questions, concerns, etc.

Leigh Ann Hutchinson understands need for most of the points, but believes some regulations are over restrictive, reading example of 4.20.1.

Zoning Agent John Valente stated that these regulations have been further developed due to complaints and are only enforced following complaints.

Chair Eric Anderson shared known global concerns of light pollution for many reasons. (i.e. affecting migratory birds and nocturnal animals).

Example: Eric Anderson's father has complained about the lighting from Andover Plaza at night as it hinders his ability to see the road whilst driving.

Leigh Ann Hutchinson asked for explanation on Section 23.5B.1.3 Lighting Standards and Requirements.

Commission discussed importance of appropriate lighting. Eric Anderson drew diagram to explain hot spots and dark area. He explained that the regulations are asking commercial properties to uniformly light their parking lot so it has roughly same illumination throughout the entire space.

Commission discussed reasoning behind importance of including checklist.

Eric Anderson explained reasoning for including the checklist in the regulations. Application is not complete until commission has a copy of the checklist filled out.

Eric Anderson acquired the checklist from the Town of Bolton, editing the document to coincide with the Town of Andover.

Eric Anderson shared edit to be made on Number 5 as it is written incorrectly. To be edited to the following sentence:

"Copy of a request for review and approval by the Fire Marshall, approval of the water supply for fire protection."
