This was originally allocated \$50,000 from CIP. Currently everything other than paving can be absorbed through contingency.

The big unknown Cost was Paving.

The original goal was to keep as much of the original pavement as possible, but all of the contractors we have talked to indicate that there is not enough structural integrity to the existing to pave over.

At this point our best option is to either remove, or recycle the existing paving, regrade Properly to drain, and repave with two lifts of 2" (compacted to 1.5") of class 1 asphalt. This will produce a slightly rougher texture, but hold up better to the heavy trucks that service our equipment.

At this point we have reviewed the paving needs with 3 paving contractors and gotten estimates from two of them. Both estimates are \$65,000 or less.

At this point I think the cleanest way to proceed is to issue an RFP (attached here) for reclaiming, regrading and paving with the alternative of striping the old asphalt instead of reclaiming.

My suggestion for paying for this is to use Locip funds. We currently have  $^{5140,000}$  and we can easily prepare a Locip grant application for this for 565,000.

To do this, we need approval from BOS as well as CIP and potentially BOF. I would like approval from the BOS before I send out the RFP.

I motion to approve the use of up to \$65,000 of LOCIP funding for reclaiming, grading and paving the Andover Transfer Station.

### **Agenda Item 4B**

In reviewing the status of the Andover Veterans memorial, there is a lot of work that should be done there to upgrade the facility

- 1. Utilize a Andover Landscape architect to design the improvements to this area
- 2. Electrical system needs upgrading- Lenco is providing us with an estimate for work required.
- 3. Plumbing- pressure tank enclosure is too small. It need to be replaced with a larger enclosure. At the same time it would be coordinated with the need for the installation of an irrigation system.
- 4. Install irrigation system
- 5. Add topsoil and reseed area- not enough topsoil for sustained lawn growth
- 6. Prep work for the site and installation of an Agent Orange monument

My question is that if we put together a proposal, would the BOS consider funding this through LOCIP? I am just looking for guidance on how to proceed. This does not need any formal motions

## **Agenda Item 4C**

The state published the rules for this round of STEAP grants after the last meeting. They are very different from previous years STEAP grants. These are designed to be quick infusions of cash for shovel ready projects.

I have called their office several times but have not gotten in contact with the program administrator yet

There are a few things that are important

- 1. The Maximum award is \$128K per municipality
- 2. This is designed for shovel ready projects Application due Aug 14, awarded Sept 14 Expectation that we begin work quickly.
- 3. 100% funding for the project must be secured. This implies the max budget would need to be 450K+128K or \$578K for the community center.
- 4. No changes in scope allowed. This is a problem because we don't even have a preliminary design so it is hard to get the scope correct for the project.

I may be missing something here, but I do not think this is a good fit for our plans for a community center. It likely represents less than 10% of the total cost of the community center. We would have to gamble that we know where the building is going.

I want a community center as much as all of you, but I think this round of STEAP funding won't work to well for what we need. I can submit a STEAP grant for the community center. I would simply modify our last submission to identify the new location. If we do it and move the location or do not finish the project in a 2-3 year timeframe- we potentially loose the money. I do not want to let the grant go to waste.

What other possible things can we apply for fast?

The most obvious is roadwork or culverts since we have some or all of the matching funds in those accounts anyway.

- 1. A paving Project like Shoddy Mill Rd, Hendy Road, long Hill, etc.
- 2. A second good option would be a Culvert Project. I spoke to Brandon today and there are multiple possibilities for Culvert Replacements, including Basola Rd and Hutchinson Rd culverts that would meet the requirements.
- 3. Another option Might be a Mini roundabout for Lake Road/ Lakeside Drive as well as realigning the intersection of Lake rd and Matheson. This would need us to hire a traffic engineer quick
- 4. The last option is my least favorite- which would be to use the money to install speed humps in the lake district. I don't think we are far enough along with this. It would be a struggle to get the preliminary plan in time

Currently on our list for Paving this year was Long Hill Rd from Rt6 to the intersection of Bear Swamp, as well as Shoddy Mill Rd from Rt 6 to just past the intersection of Wales Rd.

#### Long Hill Rd

Long Hill Rd from Riverside to Bear Swamp Rd has a PCI of 34 (rated Very poor) and from Rt 6 to Riverside a PCI of 43 (poor) which means it needs to be milled and overlaid or ground up and reconstructed. Because there is not much pavement thickness on the road less than 2.5" in many spots grinding it up is the better long term option than mill and fill. This road is has high traffic volume (priority 5) Any work will occur after the connectivity grant where the sidewalk install will disturb the pavement anyway.

#### **Shoddy Mill Rd**

Shoddy Mill Rd Between Rt 6 and Wales Rd Has a PCI of 55 (fair) It is a priority 3 road. Ordinarily with that PCI we would not address it at this time. However we need extensive drainage work on that road. That is the second priority project after the Transfer Station is complete. With the cuts required for drainage, it would be better to reclaim the rest of the road instead of patching all the cuts and then overlaying.

Given that my recommendation is to Reclaim and Pave both sections of roads

Here are the options for these roads:

If we submitted a STEAP grant for this we would be out of pocket  $^{\sim}$  265-128= \$137K from our budget

If we don't get the grant we just shim and overlay which will cost us around \$145,000.

Either way this leaves us ~ 75,000 for shimming roads this fall

I motion to authorize the town administrator to submit a STEAP grant for Reclaiming and Paving Long Hill Rd from Rt 6 Bear Swamp Road, and Shoddy Mill Rd from Rt 6 to Wales Rd
