### **Andover Fire Department Request for Replacement of Fire Truck**

The Fire Commission in conjunction with the Fire Department, is in the process of replacing two of the oldest pieces of apparatus, with one new vehicle per the 10 year capitol projection plan.

This vehicle will replace the heavy rescue, a twenty-five-year-old vehicle, and the oldest pumper, a 32-year-old vehicle with one single vehicle.

The Rescue-Pumper is built on a custom chassis and designed to carry the necessary equipment and crew members to operate efficiently.

The main function of the squad truck (a rescue/pumper) will be to carry fire fighting equipment for the extinguishment of building fires, vehicle fires, and various types of outdoor fires including brush fires. It will also carry rescue equipment like the "Jaws of Life", vehicle stabilization cribbing and air bags, and medical equipment needed at motor vehicle accidents. Also contained on this vehicle will be hazardous materials equipment for the containment of fluid spills and environmental protection, including carbon monoxide detectors and thermal imaging cameras.

At this time, three requests for proposals have been sent out. One to Pierce Manufacturing, one to Emergency One and the third to New England Fire Apparatus. We have received one response to date from New England Fire Apparatus for the price of \$915,553.00. The two other manufacturers have given verbal budget quotes between \$900,000.00 and \$1 million. They are still working on refining the prices for a written quote.

We are aware that all three manufacturers offer lease purchasing options and the one example has been included in the packet.
